BY-LAW NO. 823/21

Being a by-law of the Rural Municipality of Montcalm to regulate the licensing of raffles within the limits of the Municipality.

WHEREAS The Liquor and Gaming Control Act, S.M. 2013, c.L.153 with regulations came into force and effect December 5, 2013;

an Indian Gaming Commission is specified by the Lieutenant Governor in Council under paragraph 204(1)(b) of the Criminal Code (Canada), is specified as an authority to license charitable organizations and religious organizations located within its boundaries to conduct and manage a raffle lottery where the total prizes for each raffle lottery do not exceed three thousand dollars (\$3,000.00) council of an Indian Band, other than a council of an Indian Band located on a reserve where AND WHEREAS pursuant to Order-in-Council No. 110/2014 every municipality and every

open meeting assembled, enacts as follows: THEREFORE BE IT RESOLVED that the council of The Rural Municipality of Montcalm, in

- \Rightarrow THAT any Charitable or Religious organization located within the boundaries of the Rural Municipality of Montcalm may be granted a license to conduct and manage a Raffle Lottery where the total prizes for each such Raffle Lottery do not exceed the value of three thousand (\$3,000.00);
- 7 THAT the license fee of 1% of the estimated prize value or a minimum of \$5.00 per raffle be charged for the issuance of raffle licenses within the Rural Municipality of Montcalm;
- ω THAT the application for the raffle licenses as described above shall be in accordance with, or shall be in the form attached hereto as Schedule "A";
- 4 THAT a raffle license, if approved, shall be issued in the form attached hereto as Schedule
- 5 THAT all organizations licensed to conduct a raffle shall submit reports to the Municipality within thirty (30) days in the form attached hereto as Schedule "B";
- <u>ඉ</u> THAT the Municipality shall submit the annual Local Gaming Authority Financial Report to the Liquor, Gaming and Cannabis Authority (LGCA) for each year, not later than March 31st of the subsequent year in the form provided by the LGCA;
- 7 determining eligibility and for issuing licenses for raffles within the boundaries of the Rural Municipality of Montcalm and reporting on raffles to the LGCA; Administrative Officer, or such other person as may be designated by the Chief Administrative Officer, as Licensing Officer, who shall be with the responsibility of determining eligibility and for issuing licenses for rofficer with the responsibility of
