### RURAL MUNICIPALITY OF MONTCALM BY-LAW NO. 829/22

Being a By-law of the Rural Municipality of Montcalm to amend its By-Law No. 819/21 for the purchase of land and expansion of the lagoon and low-pressure sewer line upgrade for the town of Letellier as a Local Improvement.

WHEREAS the Rural Municipality of Montcalm, by its By-Law No. 819/21 was authorized by Municipal Board Order No. E-21-023, is inter alia, authorized to issue borrowing in the amount of \$960,000.000;

AND WHEREAS no borrowing as authorized by said By-Law No. 819/21 has been issued or sold;

**AND WHEREAS** costs were lower than expected and the total amount required to be borrowed is \$327,536.02;

**AND WHEREAS** it is deemed necessary and expedient to amend said By-law No. 819/21 to provide for a decrease in the term of the approved borrowing from 25 years to 15 years;

**AND WHEREAS** The Rural Municipality of Montcalm has received pre-payments from taxpayers in the amount of \$60,224.30; thereby reducing the amount to be borrowed from \$327,536.02 to \$267,311.72;

AND WHEREAS the Rural Municipality of Montcalm has made arrangements to borrow from the Caisse Groupe Financier in St. Jean Baptiste, MB in the amount of \$267,311.72, being the costs of works completed under the authority of By-Law No. 819/21, such borrowing to be dated January 1<sup>st</sup>, 2022, to bear interest at the rate of 3.63% per annum, payable annually during their currency, and to mature on December 31<sup>st</sup> of each of the years 2022 to 2036;

**AND WHEREAS** it is deemed expedient to amend said By-Law No. 819/21 to provide for a decrease in the term of the approved borrowing and the issuance of the aforesaid borrowing;

**NOW THEREFORE** the Council of the Rural Municipality of Montcalm in regular session assembled, enacts as follows:

- 1. **THAT** By-Law No. 819/21 of the Rural Municipality of Montcalm BE AND THE SAME IS HEREBY AMENDED to provide for decrease in the term of the approved borrowing from 25 years to 15 years.
- 2. THAT By-Law No. 819/21 of the Rural Municipality of Montcalm BE AND THE SAME IS HEREBY FURTHER AMENDED to provide that borrowing in the amount of \$267,311.72 be issued to cover the costs of works completed thereunder; such borrowing be dated the 1st day of January, 2022, to bear interest at the rate of 3.63% per annum, payable annually during their currency; and to mature in accordance with the maturities set out in Schedule "A" hereto on the 31st day of December in each of the years 2022 to 2036, both inclusive.
- 3. **THAT** Schedule "C" to said By-Law No. 819/21 be cancelled and Schedule "C" hereto be substituted therefor.
- 4. **THAT** the issue of said borrowing provides financing for all costs of works completed under authority of By-Law 819/21, and the balance of \$692,688.28 of authorized borrowing which will not be required or used is hereby cancelled.
