

THE RURAL MUNICIPALITY OF MONTCALM

BY-LAW NO. 835/22

**Being a by-law of the Rural Municipality of Montcalm
setting the indemnities payable to Council**

WHEREAS Section 124(2) and (3) of the Municipal Act of Manitoba, S.M. 1996, C58, provide as follows:

124(2) A council may by by-law set the types, rates and conditions of payments to be made to or on behalf of members of council and council committees, other than the committee of a local urban district,

- (a) as compensation for attending to municipal business;
- (b) for expenses incurred while attending to municipal business, and;
- (c) for any other purpose relating to municipal business that the council considers appropriate.

124(3) A member of a council or council committee may be paid and may accept an amount paid under a by-law passed under subsection (2).

THEREFORE the Council of the Rural Municipality of Montcalm, duly assembled, enacts as follows:

1. That the Reeve be paid as per Figure 1, effective January 1st of each year:

2. That each Councillor be paid as per Figure 2, effective January 1st of each year:

<u>Figure 2</u>	Annual Rate	Monthly Rate
2023	\$ 10,420.90	\$ 868.41
2024	\$ 10,629.32	\$ 885.78
2025	\$ 10,841.90	\$ 903.49
2026	\$ 11,058.74	\$ 921.56

3. That each LUD Committee member be paid as per Figure 3, effective January 1st of each year:

<u>Figure 3</u>	Annual Rate	Monthly Rate
2023	\$ 5,454.16	\$ 454.51
2024	\$ 5,563.24	\$ 463.60
2025	\$ 5,674.51	\$ 472.88
2026	\$ 5,788.00	\$ 482.33

4. That the Reeve and each Councillor or LUD Committee member be paid at the rates, whichever is the lesser amount as per Figure 4 for the following:

-Any special meetings other than the regular monthly council meeting.

-For meetings beyond the limits of the corporation on the business to be fixed by by-law specifying the purpose of the journey and the total amount and expenses and indemnity payable.

-For Committee meetings, supervision, and inspection of any work done for the Municipality, under authority previously given by resolution of the Council in the performance of such duties, work or services as he is required or authorized under resolution to perform.

5. That the Deputy Reeve be paid as per Figure 5 per week, over and above the Councillor rate for time where duties of Reeve are assumed.

6. That each member of council or LUD Committee receives as compensation for each kilometre travelled in a private vehicle in performance of his/her duties as a member of council a rate equal to the Government of Canada automobile allowance rate set annually for the Province of Manitoba.

7. That the Health and Benefits plans with Western Financial Group and Canada Life be paid by the Municipality for each member of Council and LUD Committee.

8. That all such compensation be paid on a monthly basis on the presentation of an approved expense form and approved by resolution of council.

9. That By-Law No. 805/19 is hereby repealed.
