

RURAL MUNICIPALITY OF MONTCALM

BY-LAW NO. 846/23

Being a by-law of the Rural Municipality of Montcalm to establish fees under the jurisdiction of *The Municipal Act, The Planning Act* and the Freedom of Information and Protection of Privacy Act

WHEREAS, subsection 232(2) of *The Municipal Act* S.M. 1996, c. P58 M225 states in part as follows:

- "232(2) Without limiting the generality of subsection (1), a council may in a by-law passed under this Division
- (d) establish fees or other charges for services, activities or things provided or done by the municipality or for the use of property under the ownership, direction, management or control of the municipality;
- (e) subject to the regulations, provided for a system of licenses, permits, approvals, including any or all of the following:
 - (i) establishing fees, and terms for payment of fees, for inspections, licenses, permits and approvals, including fees related to recovering the cost of regulation"

AND WHEREAS the Montcalm Building By-Law No. 817/20 adopts the Manitoba Building Code as required by *The Buildings and Mobile Homes Act* and applies to administration and enforcement in the design, construction, erection, placement and occupancy of new buildings, and the alteration, reconstruction, demolition, removal, relocation, occupancy and change in occupancy of existing buildings and any requirements that are necessary to correct unsafe conditions in existing buildings;

AND WHEREAS section 82 of the Regulations under *The Freedom of Information and Protection of Privacy Act* provides for and establish fees for search, preparation, copying and delivery services;

AND WHEREAS, the Municipal Council of the Rural Municipality of Montcalm deems it expedient and in the best interests of the Municipality to charge for applications and appropriate fees for services provided by the Municipality;

NOW THEREFORE BE IT RESOLVED that the Municipal Council of the Rural Municipality of Montcalm enacts in Open Council assembled as follows:

- 1. THAT fees for certain services and applications is established as set out in Schedule "A", which Schedule may be revised from time to time.
- 2. THAT the making of an application and/or payment of fees do not constitute or imply any approvals by Council.
- 3. THAT By-Law No. 816/20 be and is hereby rescinded.

4. THAT in the event of a conflicting by-law setting rates, the most recent by-law shall take precedence.
5. THAT this by-law shall take force and effect upon third reading.
